Medal Reallocations – Games of the XXX Olympiad, London 2012

Dear President,

Further to different disqualification decisions and subsequent reclassifications, we would like to inform you of the following:

- *Olympic Games London 2012 – Athletics, Women's High Jump*
Further to the decision made by World Athletics on 9 June 2021 to disqualify Svetlana Shkolina, from the Russian Olympic Committee and following the reclassification by the relevant International federation i.e. World Athletics, it is our pleasure to inform you that Ms Ruth Beitia is now placed third in the Athletics, Women's High Jump at the Games of the XXX Olympiad, London 2012.
- *Olympic Games London 2012 – Canoe Sprint, Men's C-1 200m*
Further to the decision made by the IOC Disciplinary Commission on 7 June 2019 to disqualify Jevgenij Shuklin, from the NOC of Lithuania and following the reclassification by the relevant International federation i.e. the International Canoe Federation (ICF), it is our pleasure to inform you that Mr Alfonso Bernavides Lopez de Ayala is now placed third in the Canoe Sprint, Men's C-1 200m at the Games of the XXX Olympiad, London 2012.

In order to proceed with the above-mentioned reallocations according to the new classification, we would appreciate if you could send us the following items received by Ms Beitia and Mr Bernavides Lopez de Ayala:

- Fourth place diploma

We kindly request that these items be returned to the IOC NOC Relations Department by 12 December 2021. This will allow us to send you the new medals, pins and diplomas as quickly as possible.

Following the Olympic Agenda Recommendation 17, the IOC Executive Board approved the Olympic Medal Reallocation Principles and Ceremony Options during its meeting in May 2018 to honour clean athletes who are awarded an Olympic medal following a doping case. You will therefore find enclosed the Olympic Medal Reallocation Ceremonies Principles, Guidelines for NOCs and IFs and its annexes which will assist you in this reallocation process and introduce you to the different ceremony options offered to Ms Beitia and Mr Bernavides Lopez de Ayala.

Please note that due to the current Covid-19 crisis the world is going through, the option to hold a ceremony at the Olympic Museum has been momentarily suspended. We are aiming to reinstate this option as of April 2022, provided that the national rules and restrictions applicable in Switzerland as well as IOC conditions allow it.

Please note any that reallocations can only be considered under the condition that the athlete is not under any suspension and/or that no proceedings are initiated against him/her for an Anti-doping rules violation.
